These budgets reflect a projection of the requirements necessary to ensure that the City of Gonzales continues to provide the level of services it currently provides. There are some assumptions that must be set forth that are relative to the overall operation of the city. Those assumptions are detailed below.

SALES TAX BUDGET

Sales taxes account for 70% of the revenues in the General Fund and a substantial portion of the revenues in the Capital Outlay Fund. The administration watches sales tax revenue as an important indicator of the city's ability to provide services in the future. The administration projects that the city will collect \$14,180,000 in sales taxes in the current fiscal year compared to \$14,065,000 in the previous year. This represents a 0.8% increase in sales tax revenue.

The administration has decided to take a conservative approach and set the projected sales tax revenues for the upcoming fiscal year at \$14,200,000.

Ambulance Revenues

Revenues for emergency medical services rendered by the city are expected to generate \$220,000 this fiscal year. The Fire Department is requesting authority to increase the rates charged for these services in accordance with the following table:

A market study of ambulance rates has shown that the rates charged by the City of Gonzales fall well below those rates charged by most similar jurisdictions. This increase is expected to generate an additional \$103,500 in revenue in the coming fiscal year.

Facilities Rental

The administration is also requesting an increase in fees charged for facilities rental at the City Room and Civic Center in accordance with the following table:

PERSONNEL EXPENSE

This budget projects a cost of living increase for city employees of 2%. This increase, along with health insurance increases, retirement system increases and merit increases will increase personnel expense by \$536,606, or 4.5%. Personnel cost for the City of Gonzales across all proposed budgets totals \$12,051,446.

The Municipal Employees Retirement System (MERS) employer portion of the retirement premium will increase by 3.5% percentage points to 23.25%, representing a \$183,000 increase. The employer portion of the Municipal Police Employees Retirement System (MPERS) will increase by 2.25 percentage points to 31.75%, or \$75,000.

Personnel Requests

The administration has eliminated the position of Public Information Officer. The city will attempt to provide public information services through the use of existing employees and part-time labor, creating an anticipated annual savings of \$50,000.

The Fire Department is requesting the addition of a Director of Fire Administration position within the fire department. The additional revenues from the increase in ambulance service rates are expected cover the cost of this position.

The Police Department is requesting a change to the position of Police Records Clerk, moving the three current Police Records Clerk positions from Range 4 to Range 5.

INSURANCE

General Insurance

The city's general insurance accounts, which include liability, property, and worker's compensation insurance, total \$934,631 on a budget of \$883,700. The recommended budget for all general insurance accounts is \$938,600.

Health Insurance

The city's health insurance budget will increase from \$1,528,349 to \$1,587,800 in the upcoming year, or \$59,451, which represents a 3.89% increase over last year.

The city will increase amounts paid by employees and retirees for health insurance premiums by \$50 per month in accordance with the following table:

Retiree Medicare Stipends

The City of Gonzales has traditionally paid all medically covered retirees, upon reaching the age of 65, a \$200 per month stipend to help offset the cost of health services past the age of 65. This has proven to be a costly benefit to the city, exceeding \$50,000 per year. In an effort to further control benefit spending, we are recommending ending this benefit at the end of 2016. All covered retirees currently receiving the benefit on December 31, 2016, or having attained the age of 65 by December 31, 2016, will be grandfathered-in to the program and allowed to receive the benefit. Any retirees turning 65 after December 31, 2016 will not be eligible for this program.

UTILITY FUND BUDGET

Natural Gas

We are projecting that the city will spend approximately \$500,000 on natural gas on a budget of \$725,000. The city's gas sales are expected to exceed \$1,173,000.

The city's cost of operating the Gas Department last year was \$873,592, bringing the total cost of the gas system to \$1,373,592. The natural gas rate charged by the city is a function of the price paid by the city for gas and the cost of operating the city's gas department broken down by MCF. The city sold 123,149 MCF of natural gas in 2015. The cost charged per MCF by the city will increase from \$5.84 to \$7.09 in the coming Fiscal Year.

Utility Rates

Water and sewer rates will increase 3% to keep up with inflation and the increased costs of operating the system.

DEQ STATE REVOLVING LOAN

The city currently has one outstanding loan with the DEQ State Revolving Loan Fund for Wastewater Improvements. The current loan balance is \$2,339,162. In the coming Fiscal year, the city expects to borrow \$3,000,000 against this line of credit for wastewater facilities enhancements.

In accordance with bond covenants, the city has established a "Series 2014 Bond Reserve Fund" and a "Utility Fund Investment Account", both serving the purpose of securing future loan payments in case of impending default. Current balances in these accounts total \$941,243.

CAPITAL OUTLAY BUDGET

The city is proposing a Capital Outlay Budget of \$8,823,500. The proposed Capital Outlay Budget is highlighted by \$2,400,000 in proposed road projects, \$850,000 in water and gas projects, and \$3,500,000 in proposed wastewater projects.

TANGER MALL ECONOMIC DEVELOPMENT FUND BUDGET

This fund was established in 2012 to account for revenues generated by the city's Tax Increment Financing arrangement with Tanger Mall. The tenants in Tanger Mall agreed to assess an additional 1% sales tax in a district containing only Tanger Mall tenants.

The proceeds from this additional 1% shall be allocated 70% to the Tanger Mall Economic Development Fund and 30% to the City of Gonzales. The Tanger Mall Economic Development Fund proceeds may be used for improvements to the mall property itself. The City of Gonzales portion is reserved for road infrastructure improvements within the City of Gonzales.

As of the end of March 2016, the funds reserved for road infrastructure improvements totaled \$1,213,413.

WASTEWATER IMPACT FEE FUND BUDGET

This fund was established in 2014 to account for revenues generated by wastewater impact fees instituted in that year. The March 2016 balance in the fund is \$511,120, all of which is available for use in wastewater infrastructure projects.

FUND BALANCE

The General Fund began the year with a fund balance of \$12,348,805. In the current year, the General Fund is projected to run an operational surplus of \$1,229,609. During the year, \$1,000,000 of this surplus was transferred to the Capital Outlay Fund, resulting in a projected end of year fund balance of \$12,578,412.

The Capital Outlay Fund began the year with a fund balance of \$1,956,439. It is projected to generate revenue from taxes, loans, and transfers of \$6,011,162 during the year. We project that the city will spend \$6,104,844 in the Capital Outlay Fund this year, resulting in an ending fund balance of \$1,862,756.

4. Any publicly announced candidate for any political office may lease the building upon a charge of six hundred dollars (\$600.00).
5. Any nonprofit organization with national, state, or regional affiliation and the Ascension Community Theatre may lease the building upon a charge of six hundred dollars (\$600.00).
6. Any governmental agency or the chamber of commerce shall lease the building for a fee of six hundred dollars (\$600.00).
7. A pre/post event rental fee of two hundred fifty dollars (\$250.00) shall be charged for use of the building on any evening prior to or the day after a scheduled event. Regular rent rates apply for Friday and Saturday events.
8. A security deposit of two hundred fifty dollars (\$250.00) is required at the time of booking. If the lessee does not notify the lessor of a cancellation with a period of ninety (90) days of the scheduled event, said deposit will be forfeited unless cancellation is caused by an act of God or other natural disaster.

(b) The above charges include utilities and clean-up after the event.
